As a service to our donors, we will process directed contributions from donors to organizations that are not funded partners. UWHC will charge an annual administrative fee (not to exceed ten percent (10%), capped at a maximum of \$100 per designation) to help cover the costs of vetting, collecting, processing, and distributing these donations. Designations made to UWHC funded partners, other United Ways, and Pardee, AdventHealth, or Henderson County Education Foundation will not be subject to this fee.

No goods or services were provided in exchange for this contribution. Please keep a copy of this form for your tax records. For pledges made by payroll deduction the IRS uses your pay stub, W-2 or other payroll document from your employer which show the amount withheld and paid to a charitable organization. Contributions of \$250 or more made by cash, check or credit card direct from the donor before December 31st will receive a tax receipt dated on or before January 31st of the following year.
