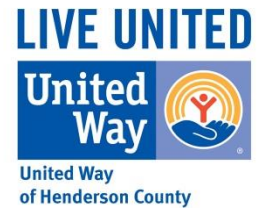


# United Way of Henderson County 2022 Program Evaluation Panels Panel Member Job Description



UWHC Program Evaluation Panel members agree to serve on a panel that reviews and evaluates applications for United Way funding every other year. Program Evaluation is a critical function that drives United Way's impact in our community. We seek to build panels that reflect the diversity of backgrounds, experiences, and perspectives that make up our Henderson County.

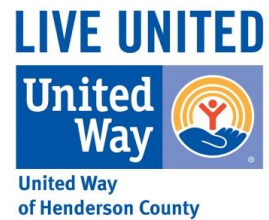
Applications and Panels are organized by UWHC's four focus areas: Education, Financial Stability, Health, and Basic Needs/Crisis Services. Members are advocates for clients who receive services, agencies that provide services, and the community at large. In addition, members act as stewards to ensure that UWHC funds are used wisely and responsibly.

### **Responsibilities include:**

- Developing familiarity with HC2025, UWHC's ten year plan to improve life for everyone in Henderson County. Panel members should agree to support the goals of HC2025 in their volunteer service and in the community.
- Thoroughly reviewing all applications for funding and supporting documentation submitted under a specific panel's focus area (Education, Financial Stability, Health, or Crisis Services/Basic Needs). Evaluating applications in a fair and unbiased manner, based on the program's quality, scope, and alignment with UWHC's HC2025 goals.
- Using UWHC's online portal to access Program applications, supporting documents, meeting minutes, and other relevant materials. Materials will only be available through the online portal.
- Helping the Panel Chair to identify and recruit future Panel members.
- Time commitment:
  - Every other year (renewable)
  - One to two hour meetings during spring allocation season (normally a total of four to six meetings over a two to three month period, February - April)
  - 2 hour training for new volunteers (includes online access training and Henderson County 2025 training/update)
